2007-08 Ministry of Education and University/ University of Calabria

Project "Gender Mainstreaming", promoted by the University of Calabria and financed by the Ministry of Education and University (Italy). Giovanna Vingelli has coordinated the project, working on the to the process of institutionalising gender in the policies, structures and human resource components of the University.

This is an on-going initiative of the Equal Opportunity Committee of the University of Calabria to institutionalise a gender perspective throughout the university, having realised that the university does not have any policies that explicitly take into account the different needs of women and men (staff and students).

This is the process that has been followed:

- A high level workshop was held for members of the staff, analysing women's and men's needs in the university and developing an action plan for meeting their gender specific needs.
- Recommendations of this workshop were presented to Senate, in order to institutionalise the whole process.
- The Senate realised that that the current status of gender issues in the university was not well established and commissioned a further study to do a situation analysis of gender related concerns university-wide. This process has not been completed.

Project "Implementation of the decision no 1554/2005 of the European Parliament and of the Council amending Council decision 2001/51 establishing a programme relating to the Community framework strategy on gender equality: Gender Budgeting in practice". (Fondazione Brodolini – Italy; University of West Bohemia, University of Pecs, Ministry of Labour and Social Policy (Bulgaria), L&S (Austria), National Training Fund (Czech Republic). Giovanna Vingelli has coordinated the work of the Italian partner, working on the "state of the art" of the gender budgeting in Europe.

The main goals of the project were to analyse a contemporary situation of gender budgeting at central, regional and local level in each partner's state and to support the implementation of gender budgeting as a standard tool in the budgetary process at regional and local level. The idea is to launch comparative analyses surveying the gender equality issues in the legal order with a view to gender budgeting and its application in practice.
